The Trustee refers to its Notice entitled **Administrative Record — Governance Consideration — Planning Permit PL-SP/05/0461 (Lal Lal Wind Farm)** previously provided for your personal attention.

For convenience only, and to assist Council's consideration of the matters raised in the Notice, the Trustee now provides a number of concise reference bundles comprising extracts from documents already forming part of the relevant administrative and public documentary record.

The material is not provided as further submissions, nor is it intended to expand upon the Notice. Rather, it is provided solely to assist Council in readily locating documentary material referred to, or otherwise forming part of, the historical administrative record relevant to Planning Permit PL-SP/05/0461.

The attached reference bundles presently comprise:

- **LLWF - Council - Planning Framework** – documents relating to the Planning Permit, endorsed planning framework, incorporated technical standards and associated regulatory material.
- **LLWF - Council - Construction & Commissioning** – contemporaneous documentary material relating to construction, commissioning and associated project milestones.
- **LLWF - Council - Compliance Reports** – extracts from background monitoring and subsequent compliance documentation.
- **LLWF - Council - FOI's & Letter** – selected Council correspondence and Freedom of Information decisions relevant to the historical administrative record.

The Trustee has also established a public documentary repository to assist agencies and interested persons in navigating the broader documentary record associated with the Lal Lal Wind Farm:
