Supplementary Public Interest Submission – Crystallised Administrative and Evidentiary Record

Lal Lal Wind Farm

Dear Sir/Madam,

The Trustee refers to its Statement of Matters of Public Interest dated 19 February 2026, together with the subsequent correspondence exchanged with the Victorian Ombudsman concerning File C/26/3280.

The Trustee further refers to the Ombudsman's correspondence confirming that the material previously provided was understood to have been submitted on a public-interest basis, was not treated as a complaint seeking a personal remedy, and had been referred internally for consideration within the Ombudsman's broader systemic oversight processes.

The Trustee now provides this Supplementary Public Interest Submission following completion of the present stage of its continuing administrative and evidentiary record concerning the Lal Lal Wind Farm.

Since the Trustee's original submission, additional statutory disclosure has occurred through Freedom of Information processes, supplementary documentary material has become available, further administrative correspondence has been completed, and the Trustee has undertaken continuing documentary reconciliation and administrative record integration. Those processes have resulted in the completion and execution of supplementary documentary material recording the present state of the administrative and evidentiary record as at 29 June 2026.

For completeness and ease of reference, the enclosed documentation includes both the Trustee's original public-interest submission and the supplementary documentation subsequently developed. Collectively, the enclosed documents present the Trustee's administrative and evidentiary record in its integrated and crystallised form as at 29 June 2026.

The Trustee emphasises that this correspondence is not provided for the purpose of requesting that the Victorian Ombudsman reopen the earlier file, reconsider previous correspondence, investigate any person or entity, determine compliance, make findings of fact or law, or provide any personal remedy.

Consistent with the methodology adopted throughout the Trustee's administrative record, the enclosed documentation distinguishes documentary chronology from conclusion, records documentary custody and administrative progression, identifies the documentary material presently available, and avoids conclusions extending beyond the disclosed record. The accompanying material is intended to preserve the integrity and continuity of the Trustee's administrative record rather than to advance advocacy or argument.

Following completion of the crystallised administrative record, the Trustee first provided the completed administrative record to Lal Lal Wind Farm Pty Ltd and its legal representatives and afforded an opportunity for constructive engagement before determining the Trustee's future administrative, regulatory or legal position. That opportunity concluded without receipt of any substantive response or indication of engagement, and the Trustee has accordingly determined that it is appropriate to provide the completed administrative and evidentiary record to the Victorian Ombudsman.

The enclosed documentation comprises the Trustee's complete administrative and evidentiary record relevant to this submission, including the original Statement of Matters of Public Interest, the Supporting Record and Analytical Memoranda, evidentiary annexes, documentary verification material, administrative chronology, explanatory documents and associated administrative continuity documentation.

The Trustee accordingly provides the enclosed material as a supplementary public-interest record associated with File C/26/3280.

The Trustee makes no request that the Victorian Ombudsman undertake any particular action in response to this correspondence. The Trustee simply considers it appropriate that the completed and crystallised administrative and evidentiary record now be provided so that it is available for such consideration as the Victorian Ombudsman considers appropriate in the exercise of its statutory functions.

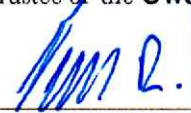
The Trustee thanks the Victorian Ombudsman for its consideration of the enclosed material.
