**Re: Lal Lal Wind Farm — Administrative Record — Departmental Reliance
Position**

Dear Minister,

The Trustee writes in its capacity as Trustee of the **Owen Robert Inter Vivos Trust** in relation to documentary material provided to the Department of Transport and Planning concerning the Lal Lal Wind Farm and Planning Permit PL-SP/05/0461-2.

The Trustee also refers to its formal submission made during the exhibition period in relation to the proposed amendment, which addressed regulatory sequencing and transitional framework considerations.

On 17 March 2026, the Trustee provided to the Department a Notice titled:

- Notice — Documentary Material Provided for Regulatory Record (17 March 2026)

together with a Supporting Record and Annex materials (A–D), for inclusion on the Department’s administrative record.

That material was subsequently the subject of follow-up correspondence confirming its receipt and placement on the administrative record.

On 30 March 2026, the Trustee wrote further, for record purposes only, noting prior Departmental correspondence (December 2023) stating that post-construction noise assessments submitted by the project proponent demonstrate compliance with NZS 6808:2010.

In that correspondence, the Trustee sought clarification, for record purposes only, as to whether the Department:

- (a) **maintains that position; or**
- (b) **considers that the additional material now forming part of the Department’s record gives rise to matters requiring further consideration in relation to that position.**

The material provided does not assert breach or seek enforcement action. It records, in structured form, elements of the presently disclosed regulatory and documentary record concerning noise assessment, application of the endorsed Noise Compliance Test Plan, auditor verification, and cross-agency reliance.

As at the date of this letter, no clarification has been provided in response to the Trustee's correspondence of 30 March 2026.

For completeness of the administrative record, the Trustee notes that separate enquiries have been made to the Lal Lal Wind Farm operator seeking documentary confirmation of the commissioning milestone referenced in regulatory correspondence, and clarification as to whether Planning Permit Conditions 23–27 have been formally discharged or satisfied by the Minister for Planning.

As at the date of this correspondence, no acknowledgement of those enquiries has been received.

This correspondence is copied to the Department for completeness of the administrative record.

The Trustee therefore writes to ensure that the current Departmental reliance position is accurately reflected on the administrative record.
