4. Future Position

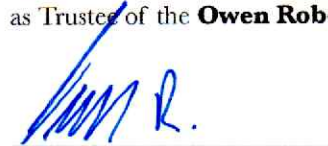
The Trustee will continue its administrative, regulatory and legal considerations having regard to the documentary record as presently reconciled.
