NOTICE — CRYSTALLISATION OF ADMINISTRATIVE AND REGULATORY RECORD

1. Purpose

This Notice is issued by **LEWIS TROJAN HORSE PTY LTD** (ACN 693 680 509) as Trustee of the **Owen Robert Inter Vivos Trust**.

The purpose of this Notice is to record that the Trustee's administrative and evidentiary record concerning the Lal Lal Wind Farm has reached a stage at which the documentary material presently available has been consolidated, analysed and incorporated into the Trustee's formal administrative record.

This Notice records an administrative event only.

It does not:

- determine compliance;
- assert breach;
- determine fault;
- determine legal rights;
- seek enforcement action; or
- request any regulatory outcome.

2. Documentary Record

The Trustee records that, as at the date of this Notice, the crystallised administrative and evidentiary record comprises, without limitation:

- (n) documentary material disclosed by Moorabool Shire Council; and

3. Crystallisation of Record

The Trustee records that:

- (d) the administrative record is intended to preserve the documentary chronology as it exists at the date of this Notice and is not intended to retrospectively alter earlier executed records.

5. Future Material

The Trustee recognises that additional documentary material may become available after the date of this Notice.

Should further documentary or administrative material become available, it may be incorporated into the continuing administrative and evidentiary record by way of supplementary documentation without retrospectively altering the record crystallised by this Notice.

6. Reservation of Rights

The Trustee is presently considering the documentary record and any future administrative, regulatory or legal steps that may become appropriate.

Nothing in this Notice constitutes:

- waiver;
- election;
- admission;
- acquiescence; or
- abandonment of any right.

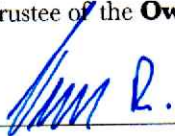
