For administrative accuracy only, the Trustee notes that the Freedom of Information request was made by:

LEWIS TROJAN HORSE PTY LTD (ACN 693 680 509) as Trustee of the **Owen Robert Inter Vivos Trust**

whereas the Notice of Decision is addressed to **Mr Owen Lewis, Director**.

The Trustee would appreciate confirmation that the Notice of Decision relates to the Trustee's Freedom of Information application made in its capacity as applicant under the *Freedom of Information Act 1982* (Vic), so that the administrative record accurately reflects the identity of the applicant.

The Trustee has also noted, on an initial review of the Notice of Decision, that the request contained an express existence-based request at **Part 4** seeking access to any document, instrument or written authority relied upon by the Department as permitting or authorising departure from the NZS 6808:2010 definitions of "Background sound level" and "Notional boundary". In the alternative, the request sought written confirmation that reasonable searches had been undertaken and that no such document was held if no responsive document existed.

The Trustee has been unable to identify any express determination of that part of the request within the Notice of Decision and would therefore appreciate clarification as to whether Part 4 was intended to be determined by the Notice and, if so, where that determination is recorded.

The Trustee will continue its review of the released material and, should any further matters requiring clarification arise following that review, will correspond separately.
