1. Purpose

This Notice records the completion of the procedural opportunity previously afforded by the Trustee to Mr Gustaf Reuterswärd following issue of the Trustee's Notice — Opportunity to Clarify Professional Positions and Authorising Basis — Procedural Fairness — Lal Lal Wind Farm, dated 26 July 2026.

The earlier Notice invited Mr Reuterswärd to identify any documentary material, authorising instrument, technical basis or other documentary explanation relevant to the matters identified by the Trustee.

This Notice forms part of the Trustee's continuing administrative and evidentiary record.

2. Subsequent Material Provided

Following issue of the Notice, the Trustee provided Mr Reuterswärd with further material for information and to ensure that any response he might choose to provide could be made having regard to the developing documentary record.

That material included:

- additional documentary material concerning Special Audible Characteristics, notified on 29 July 2026; and
- the Department of Transport and Planning's Freedom of Information clarification dated 4 August 2026, notified on 5 August 2026.

The Trustee expressly advised on each occasion that the additional material did not amend or otherwise alter the Notice dated 26 July 2026.

3. Completion of Procedural Opportunity

The Trustee considers that a reasonable opportunity has now been afforded to identify any additional documentary material, authorising document, technical basis or documentary explanation responsive to the matters identified in the Notice dated 26 July 2026.

As at the date of this Notice, the Trustee has not received a substantive response identifying such additional material or otherwise addressing the matters raised in the earlier Notice.

Accordingly, the Trustee considers that the procedural opportunity afforded for that purpose has now concluded.

The Trustee will proceed on the basis of the documentary record as presently reconciled.

4. Continuing Administrative and Evidentiary Record

This Notice does not expand upon, amend or restate the substantive matters contained in the Trustee's Notice dated 26 July 2026.

Its purpose is to record the completion of the procedural opportunity previously afforded.

Should Mr Reuterswärd subsequently identify documentary material relevant to the matters addressed in the earlier Notice, the Trustee remains willing to receive and consider that material as part of its continuing administrative and evidentiary record.

5. Future Position

The Trustee will continue its administrative, regulatory and legal considerations having regard to the documentary record as presently reconciled.

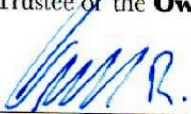
