Re: Formal Notice of Trustee Authority and Administration of Existing Rights, Claims, and Obligations – **Owen Robert Inter Vivos Trust**

Dear Ms Asten,

For the purposes of this notice, the term "**Legal Name**" means "**Owen Robert LEWIS**", including any derivative, variant, alias, inversion, abbreviation, formatting, or administrative representation of that name as appearing in prior records, correspondence, contracts, or dealings.

This letter serves as formal notice that the **Owen Robert Inter Vivos Trust** was duly executed on 15 December 2025, and that **LEWIS TROJAN HORSE PTY LTD** (ACN 693 680 509) has been appointed and is acting as **Trustee** of that trust.

Accordingly, with effect from execution:

- The **Trustee** now administers, manages, and enforces all existing and future rights, obligations, claims, causes of action, contracts, and commercial processes that were previously held, asserted, or exercised by the **Beneficiary** in a private capacity and/or under the **Legal Name** "Owen Robert LEWIS", and which are held on trust for Owen Robert (**Beneficiary**).
- This notice does not create new rights, nor does it vary the substance of any existing arrangements. It records a change in administration and authority, whereby the **Trustee** now stands in the proper capacity to correspond, negotiate, resolve, and (if required) prosecute or defend matters relating to those rights and obligations.
- All prior dealings, correspondence, invoices, notices, and assertions are preserved as commercial history and are now administered by the **Trustee** without interruption or waiver.

For the avoidance of doubt, the **Trustee** will also rely, as part of the evidentiary record, upon certain prior acts, affidavits, proclamations, correspondence, and annexes authored by the **Beneficiary** in a private capacity, including documented material evidencing alleged harm (including material commonly referenced as **Annexe 4**). While such material is acknowledged as non-determinative and non-binding of itself, it forms part of the factual matrix and contemporaneous record upon which the **Trustee** may rely in the administration, assessment, and resolution of matters.

This reference is made without argument and without prejudice, solely to place recipients on notice that such material exists and may be relied upon as evidence, together with supporting documentation, should resolution not be achieved by engagement.

It is not intended to create new obligations, vary existing arrangements, or alter the substantive rights of any party. Recipients are invited to acknowledge receipt and engage with the **Trustee** to facilitate the orderly resolution and administration of matters within its authority.
