makes the following formal enquiry pursuant to the Lal Lal Wind Farm Community Engagement Policy and the Complaints and Enquiries Procedure (OEMP Condition 8).

The published Community Engagement Policy states that Lal Lal Wind Farm is committed to:

“meaningful engagement with stakeholders and the community,”
“providing clear, timely and accessible information,” and
engagement conducted in a “transparent and respectful manner.”

Further, the Complaints and Enquiries Procedure provides that:

A copy of the commissioning certificate (or equivalent commissioning completion document) for the final turbine referenced above.

Given that the commissioning date has been formally asserted in regulatory correspondence, the Trustee does not seek commercially sensitive contractual material, but rather documentary confirmation of the commissioning milestone referenced.

This enquiry is made for administrative record purposes only. No allegation is made.
